1. Welcome and Introductions

PK gave site induction presentation.
Introductions were made as there are new faces at the CLG.

2. Actions from last meeting

All completed – HPC website is undergoing an overhaul so updates and minutes will be uploaded as soon as that is done.

3. Update on EnviRecover – from Paddy Kelly

The Energy-from-Waste facility is running well since official handover on 3rd March 2017. It has had 96% availability in March in terms of the boiler;. There was one drop of 27hours due to chassis of small car getting into the waste stream and into boiler, 2 weeks after handover. This has proved to be a good experience for whole team as we had to deal with a tricky situation requiring significant manual intervention. Both departments reacted well and the lessons learnt have been added into procedures.

For April, we've had 100% availability so far.

Average electrical export in March was 18.5MWh, which is better than predicted. There will be generation drop off as the months warm up.

The emissions data is available on the website providing a snap shot of emissions for the month, the process, regulation and biodiversity.

In terms of vehicle movements – March: Mondays are light 60 in total, Tuesday – Friday there is 100 and Saturday has 30. 88% are waste inputs, 9% is IBA out, and the remaining is APCr going out.

The Biodiversity plan is coming into action with refuges, habitats and transit routes. 100% of the APC has been recycled since mid-November (carbon negative construction material).

The IBA reprocessing contract has been signed with the first batch starting at H&M landfill in May.

The full team has been recruited and the HZI competency training has also been completed.

PT: What is the name of company?

PK: Carbon8 (It is a Grundons partnership, down at Avonmouth)

GH: Are you pre-processing on site?

PK: No, the powder is gathered from flue gas treatment centre with all processing at Avonmouth.

PT: What about the IBA?

PK: We've been holding it at H&M. It will also be reprocessed at H&M following a permit amendment. This removes the metal content leaving us with nicely aggregated content.

DI: What about the chassis? Can you stop it from happening again?

PK: We've issued a notification out to authorities to alert and step up inspection; we do daily inspections.

PT: How come it wasn't spotted in the bunker?

PK: The Grab can hold 6 tonnes of waste in one go so things can get through. The word is out through to the Councils and we remain vigilant.

4. Feedback from Mercia

KS: We've not had any real feedback. We had the soft opening last month, which was well attended as an informal event to mark handover. We are still hoping for more formal opening in June/July.
