4.0 Severn Waste Services Report

4.1 A copy of the Severn Waste Services (SWS) Operational Report - January 2019 was distributed to the group.

Ana Gonzalez presented the SWS report, advising the following:

4.2 Landfilling activities continue in Cell 5.4 until April 2019 and will then revert back to Cell 5.3.

4.3 The restoration and capping of Cell 5.3 will be carried out in 2020.

There have been four schedule 5 notifications during the above period:

- 4.4 <u>16 October 2018</u> Breach of Chloride in discharge consent DC2 . A level of 259 mg/l was detected against a limit of 250 mg/l.
- 4.5 <u>19 November 2018</u> Breach of Chromium in discharge consent LDC. A level of 0.206 mg/l was detected against a limit of 0.2 mg/l.
- 4.6 <u>22 November 2018</u> Breach of CO2 in boreholes BH10, BH8 and GM2.

^{4.8} Michael Hornby advised the Group that the Breaches of methane occurred on the old part of the landfill which is not as well engineered as current cells.

Michael Hornby stated that historically there were 6 Engines in operation and now there are 4 engines on site (1 spare) of which 3 are powered by methane to generate electricity for export to Grid.

- 4.9 Incinerator Bottom Ash (IBA) which has been stockpiled on site since May 2018 will be processed in May / June 2019.
- 4.10 Vincent Connor will invite Cllr Tucker and CLG members to view the IBA screening by *RockSolid* when they mobilise next. **VGC**
- 4.11 Michael Hornby advised that a national decision/statement by the Environment Agency regarding IBAa end of waste criteria is now expected to be made in Autumn 2019.
- 4.12 Cllr L Tucker enquired where on site BH7 and BH8 are located?

Michael Hornby advised that they were on the old part of the landfill and not shown on the Cell Location map within the Report.

4.13 Cllr L Tucker asked for qualification of the Household Recycling Centre Recycling Rate for 2018?

Michael Hornby confirmed that the Household Recycling Centre recycling rate was 71.5% for 2018.

4.14 Charles Tucker asked for details on 16 November 2018 - Breach of Chloride?

Michael Hornby stated that this was detected within surface water run-off and may have been the result of 'concentration' of chemical on site.

4.15 Charles Tucker asked for details on 19 November 2018 - Breach of Chromium?

Michael Hornby stated that levels are monitored throughout the year and levels are 'Balanced' if any one area demonstrates an increase.
